ORDINANCE NO. 01 - 2019

AN ORDINANCE AUTHORIZING THE FORMATION OF A UNION CEMETERY DISTRICT AND DECLARING AN EMERGENCY

WHEREAS, the City of Waterville, Village of Whitehouse and Waterville Township have united in the establishment and management of a cemetery under *R.C.* 759.27;

WHEREAS, the City, Village and Township wish to form a union district for establishment, operation, and maintenance of cemeteries as authorized by *R.C.* 759.341;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF WHITEHOUSE, LUCAS COUNTY, OHIO, three-fourths (34) of all members elected thereto concurring:

<u>Section 1.</u> The Council for the Village of Whitehouse hereby authorizes the formation of a union cemetery district to include the City of Waterville, the Village of Whitehouse, and Waterville pursuant to *R.C.* 759.341. The Administration is directed and empowered to execute all documents necessary to effectuate this formation.

<u>Section 2</u>. The District shall be comprised of all the territory within the united municipalities and township.

<u>Section 3.</u> The District shall be organized, operated and have those powers specified in *R.C.* 759.341.

<u>Section 4</u>: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted at open meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public in compliance with legal requirements as set forth by Village Charter.

<u>Section 5.</u> This Resolution is hereby declared to be an Emergency Measure necessary for the immediate preservation of the public peace, health, and safety; and for the further reason that this resolution is deemed necessary to have this legislation in place in order to provide for the creation of a cemetery district as soon as possible.
